Promotion Terms, Rules and Regulations

- 1. All Participants in The Otsego County Chamber of Commerce (OCCC) Shop Small, Win Big promotion, resulting in a prize or award, must be 21 years or older to win, unless otherwise specified. Satisfactory proof of identification and age must be presented before claiming a prize.
- 2. This promotion begins on November 26, 2022 at 8:00am Eastern Time and ends on December 17, 2022 at 11:59pm Eastern Time.
- 3. To enter, a entrance slip must be filled out at participating business location during the promotion timeframe described above.
- 4. Per Location Promotion: One winner per location will be selected, at random, at each location on Monday, December 19, 2022. When notified of their selection that winner must come to that participating business location and select one of five balloons on display. The slip of paper within the selected balloon will display an amount between \$25.00 and \$75.00. The winner will receive an in store credit in the amount shown on the slip of paper within the balloon selected.
- 5. Grand Prize Promotion: On or before December 21, 2022, all entry slips collected from all participating locations will be combined and one Grand Prize Winner will be selected. That winner will receive a \$500 Visa[®] Gift Card.
- 6. A person cannot enter on behalf of another person.
- 7. There may only be one winner of any Otsego County Chamber of Commerce promotion per household, per location drawing during this promotion.
- 8. OCCC is not responsible for lost or delayed mail, for telephone or fax equipment failures, or for e-mail system malfunctions causing a contestant to lose or delay the chance to participate.
- 9. OCCC will keep a file of customized rules for each promotion.
- 10. Employees of OCCC, and persons involved with providing the prize or award, or the immediate families of such employees and persons, are not eligible to participate or win.
- 11. Winners are responsible for any and all taxes associated with winning the prize.
- 12. Prizes have no cash equivalent and are not transferable.
- 13. OCCC management will have sole discretion to decide any questions concerning the interpretation of rules governing the promotion and the administration of the promotion, and such decisions shall be final.
- 14. The promotion rules may be amended at any time by OCCC management without prior notice. However, all changes will be published on the OCCC website and effective as of that date.
- 15. In the case of a tie, OCCC reserves the right to choose the winner by any method it deems appropriate.
